

## **2016 COMMUNITY BANKING MONTH GIVEAWAY Contest Rules and Restrictions**

### THE FIRST NATIONAL BANK “COMMUNITY BANKING MONTH GIVEAWAY” CONTEST OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN

#### **1. Eligibility:**

THE FIRST NATIONAL BANK (FNB) “COMMUNITY BANKING MONTH GIVEAWAY” CONTEST (the “Contest”) is open only to legal residents of the 50 United States (or the District of Columbia), who are 18 years of age or older at the time of drawing. The Contest consists of entries from 4/1/2016 to 05/02/2016, leading to the Grand Prize Drawings to be held approximately on May 3, 2016 at each FNB branch location (Hartford, Richfield and Slinger) at a time TBD. The Grand Prize Winners do NOT need to be present at time of drawing and must provide proof of age at the time of pickup of the Grand Prize. Employees of FIRST NATIONAL BANK and the immediate family (spouse, and children) living in the same household of each such person are not eligible. The Contest is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

#### **2. Grand Prizes:**

There will be three grand prize winners, one from each FNB branch location – Hartford, Richfield and Slinger. The winners of the Contest will each receive one \$250 MasterCard® gift card. The winners of the Grand Prize are responsible for any sales taxes and any personal income taxes owed according to IRS rules.

The contest runs from 4/1/2016 through no later than 05/02/2016, with the winners being announced around 05/03/2016.

#### **4. Agreement to Official Rules:**

Grand Prize Winners: One (1) Grand Prize Winner from each FNB branch (Hartford, Richfield and Slinger) will be determined around May 3, 2016. Winners will be chosen randomly. The Grand Prize winners must provide proof of age at the time of pickup of the Grand Prize, and do not need to be present to win.

Prizes may not be transferred before pick up by the selected winner. The Grand Prize winners may waive his/her rights to receive the \$250 gift card. The Grand Prize is non-assignable and nontransferable. No substitutions will be awarded or allowed. In the event the winner waives his/her right to receive the grand prize, FIRST NATIONAL BANK OF HARTFORD, reserves the right to award the grand prize to the next individual who is drawn from the entries at that branch.

#### **6. How to Enter:**

Entrants will obtain a "Community Banking Month Activity Card" from the bank, the bank's website or the bank's Facebook page. Entrants will complete the activities and bring their completed activity square to the bank for verification, upon which the entrant will receive an entry into the contest. FIRST NATIONAL BANK OF HARTFORD reserves the right to and may provide additional entries at its discretion to customers for any reason and under any circumstances (for example, if a customer had to wait some time to be helped, FIRST NATIONAL BANK OF HARTFORD may award an entry to the customer for their patience and inconvenience).

You may receive only ONE (1) entry for completing each activity on the activity card. There are a total of 20 activities, so entrants can receive up to 20 entries by completing the entire activity card. ## **8. Publicity:**

Except where prohibited, participation in the Contest constitutes entrant's consent for FIRST NATIONAL BANK OF HARTFORD to use entrant's name, likeness, prize information, city and state of residence for promotional purposes in any media without further consideration.

## **9. General Conditions:**

In the event that the security, operation, or administration of the Contest is impaired in any way for any reason, FIRST NATIONAL BANK OF HARTFORD may, in its sole discretion, either: (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Contest and award the Grand Prizes in a random drawing from among all eligible entries received up to the time of the impairment. FIRST NATIONAL BANK OF HARTFORD reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of the Official Rules, or in an unsportsmanlike or disruptive manner. FIRST NATIONAL BANK OF HARTFORD's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

## **Release and Limitations of Liability:**
