2020 COMMUNITY CONNECTION SOCIAL MEDIA GIVEAWAY Contest Rules and Restrictions

FORTE BANK "COMMUNITY CONNECTION SOCIAL MEDIA GIVEAWAY" CONTEST OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN

1. Eligibility:

FORTE BANK "COMMUNITY CONNECTION SOCIAL MEDIA CONTEST" (the "Contest") is open only to legal residents of the 50 United States (or the District of Columbia) who are 18 years of age or older at the time of drawing. Entrants do NOT need to be customers of FORTE BANK. The Contest consists of entries from 9/21/2020 through no later than 12/14/2020, with winners being chosen approximately every two weeks. Winners do NOT need to be present at time of drawing and must provide proof of age at the time of pickup of the prize. Employees of FORTE BANK and the immediate family (spouse, and children) living in the same household of each such person are not eligible. The Contest is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

2. Prizes:

5. Competitions/Winner Selection:

There will be at least four winners and possibly six winners if the contest extends through 12/14/2020. Winners will be chosen approximately every two weeks. Winners will be chosen randomly. The prize winners must provide proof of age at the time of pickup of the prize and do not need to be present to win.
